

ORDER NO. 28
GRANTING MOTION FOR EXTENSION OF TIME

On October 17, 2016, TJFA, LP and the Environmental Protection in the Interest of Caldwell County (Protestants) filed a motion to extend the time to file closing arguments by one business day. The Protestants allege that additional deadlines in other cases have arisen since the briefing schedule was originally set, and the extension would allow the Protestants adequate time to prepare their closing arguments. The Protestants represent that none of the other parties oppose the request.

Accordingly, the Protestants' October 17, 2016 motion is **GRANTED**, and the deadline for all the parties to file closing arguments is extended to **October 24, 2016**.
