ORDER NO. 30  
GRANTING AGREED MOTION TO EXTEND TIME FOR  
FILING RESPONSES TO CLOSING ARGUMENTS

On November 16, 2016, 130 Environmental Park, LLC, (130 EP) filed a motion seeking additional time for all parties to file responses to the written closing arguments previously filed in this case. The current deadline for such responses is November 18, 2016 and the motion requests that the deadline be extended to November 22, 2016. 130 EP represents in the motion that all parties except Ben Pesl have agreed to this deadline extension. However, Mr. Pesl did not appear and participate at the hearing on the merits and did not file a written closing argument.

The Administrative Law Judges (ALJs) find that the motion has merit, but extend the deadline to **November 28, 2016**. Therefore, the deadline for all parties to file responses to closing arguments, and the record close date, is now **November 28, 2016**, and the proposal for decision will be due on January 27, 2017.
